ROUTINE PROCESSING - WHICH USUALLY TAKES ABOUT 6 WEEKS FOR *PASSPORT BOOKS*

16 YEARS AND OLDER - \$75.00 MUST BE **CHECK OR MONEY ORDER** (NO CASH)

YOUNGER THAN 16 - \$60.00 MUST BE **CHECK OR MONEY ORDER** (NO CASH)

For *PASSPORT CARDS* – Available Spring 2008

16 YEARS AND OLDER- \$20.00 MUST BE **CHECK OR MONEY ORDER** (NO CASH)

YOUNGER THAN 16- \$10.00 MUST BE **CHECK OR MONEY ORDER** (NO CASH)

MADE PAYABLE TO **U.S. DEPARTMENT OF STATE**

EXPEDITE PROCESSING – WHICH USUALLY TAKES ABOUT 3 WEEKS

BRING TO OUR OFFICE ALONG WITH FEES AND APPLICATION:

Q **2 PASSPORT PHOTOS** – COLOR, 2" X 2" , identical, headsize no smaller than 1" and no larger than 1 3/8", taken on white or off-white background. There must be at least a 1/2" from the top of the head to the top of the photo.

Now available at our office for a fee of \$8.00

Q **PROOF OF CITIZENSHIP** – **THIS DOCUMENTATION MUST BE SUBMITTED WITH THE APPLICATION**

EITHER:

BIRTH CERTIFICATE, with a raised seal and filing date, certified by official custodian of the record (NO HOSPITAL CERTIFICATES) For applicants under age 16, must have both parents names on certified copy.

OR

PREVIOUS PASSPORT (for applicants under age 16 see handout mentioned below)

OR

NATURALIZATION CERTIFICATE

Q **IDENTIFICATION** – Valid Drivers License, Previous Passport (if issued after 18th birthday and within in the last 10 years), Current College I.D. Parents who are not U.S. citizens must present their foreign passport or their alien registration card as identification when signing for their children. Parents who are U.S. citizens can use their drivers license when signing for their children.

ALL APPLICANTS MUST APPEAR IN PERSON AND SIGN THE APPLICATION IN THE PRESENCE OF A PASSPORT AGENT. APPLICANTS UNDER AGE 16 MUST HAVE BOTH PARENTS APPEAR WITH THEIR IDENTIFICATION. SEE HANDOUT (U.S. PASSPORT APPLICATIONS FOR CHILDREN UNDER AGE 16) FOR COMPLETE INSTRUCTIONS.
